# Organizational Meeting Record of Proceedings January 4th, 2021- 6:30 o'clock P.M.

Meeting was called to order by Fiscal Officer Marko F. Jesenko and the Pledge of Allegiance was given.

Trustees Fry, Bright, and Wetzel, Fiscal Officer Jesenko and Zoning Inspector Witney were all present.

Fiscal Officer Jesenko asked for nominations for Chairman for 2021. Tr. Bright nominated Tr. Wetzel for Chairman. Seconded by Tr. Fry. Vote: Bright- yes, Fry- yes, Wetzel- abstain.

Tr. Wetzel nominated Trustee Fry for Vice Chairman. Seconded by Tr. Bright. Vote: Fry- abstain, Bright- yes, Wetzel- yes.

- 1) Tr. Wetzel made the following resolution and moved its adoption: to post special and emergency meeting notices at the township hall, on the township website, and in the newspaper as time allows. Seconded by Tr. Bright. Vote: Fry- yes, Bright- yes, Wetzel-yes.
- 2) Tr. Wetzel made the following resolution and moved its adoption: to hold Jersey Township Trustee monthly meetings on the first Monday of each month. If a holiday should fall on the first Monday, the meeting will be moved to the first Wednesday of the month. All monthly township trustee meetings will be held at the Jersey Township building and all regular monthly meetings will be called to order at 7:30 P.M. All monthly meetings will follow this schedule unless advertised otherwise. Seconded by Tr. Fry. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 3) Tr. Wetzel made the following resolution and moved its adoption: that trustees and road crew may purchase parts for equipment costing \$2500.00 or less. If an emergency arises, road crew member must contact one trustee for purchases up to \$7500.00. Seconded by Tr. Fry. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 4) Tr. Wetzel made the following resolution and moved its adoption: that the fiscal officer is authorized to purchase necessary office equipment and supplies as needed. Seconded by Tr. Fry. Vote: Fry- yes, Bright- yes, Wetzel-yes.
- 5) Tr. Wetzel made the following resolution and moved its adoption: that Tr. Wetzel represent Jersey Township on the West Licking Joint Fire District Board. Seconded by Tr. Fry. Vote: Tr. Fry- yes, Tr. Bight- yes, Tr. Wetzel- abstained.

- 6) Tr. Wetzel made the following resolution and moved its adoption: that Tr. Bright represent Jersey Township on the Southwest Licking Water and Sewer District. Seconded by Trustee Fry. Vote: Tr. Bright- abstain, Tr. Fry-yes, Tr. Wetzel- yes.
- 7) Tr. Wetzel made the following resolution and moved its adoption: that Tr. Bright represent Jersey Township on the Raccoon Valley Water and Sewer District. Seconded by Trustee Fry. Vote: Tr. Bright- abstain, Tr. Fry- yes, Tr. Wetzel- yes.
- 8) Tr. Wetzel made the following resolution and moved its adoption: that the fiscal officer is authorized to move money between accounts within a fund as needed. Seconded by Tr. Bright. Vote: Tr. Fry- yes, Tr. Bright- yes, Tr. Wetzel- yes.
- 9) Tr. Wetzel made the following resolution and moved its adoption: that the fiscal officer is authorized to use blanket certificates in addition to purchase orders when encumbering funds. Seconded by Trustee Fry. Vote: Tr. Fry- yes, Tr. Bright- yes, Tr. Wetzel- yes.
- 10) Tr. Wetzel made the following resolution and moved its adoption: that as roadmen are paid every fourteen days, other township employees may turn in their time sheets to be paid every fourteen days as well, rather than once a month. Seconded by Tr. Fry. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 11) Tr. Wetzel made the following resolution and move its adoption: that if an invoice needs to be paid between monthly meetings, the fiscal officer has the authority to pay the invoice with at least two trustee signatures on the warrant. Seconded by Tr. Bright. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 12) Zoning/ Zoning Appeal Board vacancies- Tr. Wetzel made the following resolution and moved its adoption: that Danny Howser be reappointed to new term on the Board of Zoning and that Ruth Ann Booher be reappointed to a new term on the Board of Zoning Appeals. Seconded by Tr. Fry. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 13) Tr. Wetzel made the following motion and moved its adoption: that the temporary housing permit deposit of \$500.00 be remanded to Jersey Township, which will be refunded when residence is established in the new home and the trailer is removed. Seconded by Tr. Bright. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 14) Tr. Wetzel made the following motion and moved its adoption: to charge 25 cents per page for minutes/records and ten dollars per compact disc to any person requesting copies of township minutes. No copies will be mailed. They are to be picked up at the township hall at the fiscal officer's convenience. No written request for minutes should be submitted before a meeting takes place and a time span of at least two weeks should be allowed to receive minutes. Approved minutes shall be posted on the township website. Seconded by Tr. Bright. Vote: Bright- yes, Fry- yes, Wetzel- yes.
- 15) Tr. Wetzel made the following motion and moved its adoption: that the Jersey Township Boards of Zoning and of Zoning Appeals maintain the charge of \$500.00 per hearing. If a court reporter is required, it will be at the expense of the applicant. Fees for a commercial building permit of \$500.00 up to 1000 square feet and 30 cents per square

- foot over 1000 square feet or any part thereof. Seconded by Tr. Bright. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 16) Tr. Wetzel made the following motion and moved its adoption: to pay the Jersey Township Zoning Secretary \$110.00 per meeting attended. Seconded by Tr. Fry. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 17) Tr. Wetzel made the following resolution and moved its adoption: that Jersey Township reimburse expenses of trustees, fiscal officer, zoning inspector and road crew members attending the Ohio Township Association Convention. Additionally, that Jersey Township reimburse expenses for a single trustee or the fiscal officer attending the National Township Convention in Washington, D.C. Seconded by Tr. Bright. Vote: Fry- yes, Bright-yes, Wetzel-yes.
- 18) Tr. Wetzel made the following resolution and moved its adoption: to pay mileage when outside of Jersey Township on township business at the rate set by the Internal Revenue Service. Seconded by Tr. Bright. Vote: Fry- yes, Bright- yes, Wetzel- yes
- 19) Tr. Wetzel made the following motion and moved its adoption: to authorize the Jersey Township Fiscal Officer to request from the Licking County Auditor advance against any real estate taxes collected for the benefit of Jersey Township. Seconded by Tr. Fry. Vote: Fry. yes, Bright- yes, Wetzel- yes.
- 20) Tr. Wetzel made the following motion and moved its adoption: township cell phones shall be used for township purposes. Use of cell phones for non-township communication shall be kept to a minimum. Seconded by Tr. Fry. Vote: Fry- yes, Bright-yes, Wetzel-yes.
- 21) Tr. Wetzel made the following motion and moved its adoption: township trustees shall use the salary method of payment, not per diem, to the maximum compensation allowed; Ohio Revised Code 505.24. Seconded by Tr. Bright. Vote: Bright- yes, Fry yes, Wetzel- yes.
- 22) Tr. Wetzel made the following motion and moved its adoption: to approve the fiscal officer's salary according to maximum compensation allowed; Ohio Revised Code 507.09. Seconded by Tr. Fry. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 23) Tr. Wetzel made the following motion and moved its adoption: to pay part time road or cemetery help \$15.00 an hour and to pay part road or cemetery time help holding a Commercial Driver's License and/or performing tar and chip labor \$20.00 an hour. Seconded by Tr. Bright. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 24) Tr. Wetzel made the following motion and moved its adoption: to pay Zoning Board and Zoning Appeal Board members \$55.00 per meeting attended. Seconded by Tr. Fry. Vote: Fry- yes, Bright- yes, Wetzel- yes.

- 28) Tr. Wetzel made the following resolution and moved its adoption: to award the zoning inspector Earnest G. Witney IV (Bud) a 3% pay increase. Seconded by Tr. Fry. Vote: Fryyes, Bright-yes, Wetzel-yes.
- 29) Tr. Wetzel made the following motion and moved its adoption: to award administrative assistant Kathy M. Wetzel a 3% pay increase to take effect on the first full two week pay period of calendar year 2021. Seconded by Tr. Fry. Vote: Fry- yes, Bright- yes, Wetzelabstain.
- 30) Tr. Wetzel made the following resolution and moved its adoption: that the township operate on carryover funds until a permanent annual budget is approved. Seconded by Tr. Fry. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 31) Tr. Wetzel made the following resolution and moved its adoption: to advertise for stone to be used on various roads in Jersey Township. Limestone prices needed for 8's, 57's, washed 8's, washed 57's, 411's, 304's, 2's, and D-Rap limestone. Pricing for pulverized top soil also needed. Bids should be sealed and addressed to: Jersey Township Trustees, care of Marko F. Footers exceeding five feet in length shall cost an additional 65 cents per square inch of length. Footers are to be installed by township employees only and must be completed by November 1<sup>st</sup> or wait until March 1<sup>st</sup>, weather permitting, for installation. Seconded by Tr. Bright. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 33) Tr. Wetzel made the following resolution and moved its adoption: open and close fee for cremation; \$150.00. Seconded by Tr. Fry. Vote: Fry yes, Bright- yes, Wetzel- yes.
- 34) Tr. Wetzel made the following resolution and moved its adoption: head stone size limits shall be maximums of 10 feet in length and 18 inches in width. Seconded by Tr. Fry. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 35) Tr. Wetzel made the following resolution and moved its adoption: grave opening and closing fee: \$525.00 on weekdays, \$800.00 on Saturdays. There will be no burials on

- Sundays or holidays and Saturday burials must be in the cemetery by noon. Seconded by Tr. Fry. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 36) Tr. Wetzel made the following resolution and moved its adoption: township resident cemetery lot fee (with a lot holding three graves) shall be \$600.00 per lot. Non- resident fee shall be \$2500.00 per lot. There shall be a limit of two lots per household. Seconded by Tr. Bright. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 37) Tr. Wetzel made the following resolution and moved its adoption: to follow the current agenda for public meetings, (which was adopted by the township on January 4<sup>th</sup>, 1999 upon recommendation of the county prosecutor,) during calendar 2021. Seconded by Tr. Bright. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 38) Tr. Wetzel made the following resolution and moved its adoption: that the fiscal officer is authorized to retain help when needed with the UAN (Uniform Accounting Network) software program provided by the Auditor of State. Seconded by Tr. Fry. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 39) Tr. Wetzel made the following resolution and moved its adoption: that the township offer the following for purchase to residents at cost to township; the Jersey Township Zoning Resolution Book (\$57.00), the Jersey Township Comprehensive Plan (\$69.00), and the West Licking Accord (\$63.00). Seconded by Tr. Fry. Vote: Fry- yes, Bright- yes, Wetzel- yes.
- 40) Tr. Wetzel made the following resolution and moved its adoption: that the Organizational Meeting for each new year be held at 6:30 o'clock P.M. on the first Monday of January of that new year immediately previous to the regular monthly meeting.
