**Section 1.** The Board authorizes the Road Superintendent, Administrator, or Fiscal officer to seek sealed bids from suppliers of the following materials: #8 limestone; #57 limestone; #2 limestone, #411 and #304 limestone; D-rap limestone; #57 gravel; and pulverized topsoil

**Section 2.** The Board will open the sealed bids at its February 6, 2023 Regular meeting. As such, the bids must be received no later than 12:00 noon on February 6, 2023.

**Section 3.** It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.
